ARTIST CONTESTANT /PERFORMER RELEASE

This release is made to allow Jackpot Pictures, LLC ("Company" or "you") to consider my submission of "Materials" (as defined, below), for inclusion in the battle of the bands contest ("Contest") for ultimate possible selection of my Materials to be included in the production and/or publication tentatively entitled Moments of Youth (the "Programming"). I am giving this release in consideration for Company allowing me to participate in the Contest and potentially be featured in the Programming and I recognize that my signature on this release is a condition of your permitting me to be considered for the Contest and in the Programming or both. I will submit a master recording ("Master") of my original performance of an original composition ("Composition"), along with videos of such performance ("Videos"), pictures of myself ("Pictures"), and my logo ("Logo"), if any. The Master, Composition, Videos, Pictures and Logo, are collectively referred to herein as the "Materials." I agree that by submitting the Materials, I explicitly authorize Company and Company's licensees and assigns the non-exclusive right to post, share, use, perform, display, and otherwise exploit the Materials, for the duration of the Contest and, if selected as a winner of the Contest, I hereby grant to you the non-exclusive right to use the Materials in the Programming, in your sole discretion, in any and all media, in perpetuity. I agree that, in the event that I am selected to perform in the Programming, you may tape and photograph me and record my voice and conversation including quotes, paraphrases, sounds, including, but not limited to any performance of an original musical composition(s), for use in and in connection with the Programming (the "Performance"). I also understand and agree that this Programming is a non-guild production and there will be no residual or any other type of payment due in connection with my Performance.

I agree that you shall be the exclusive owner of all copyright and other rights in and to the Programming and Performance and will be able to use them forever and throughout the world, and to license others to use them, in any manner you wish and in any and all media now known or hereafter discovered or developed.

I further irrevocably agree that you may use and license others to use the Performance or excerpts there from, and my name, voice, likeness and any biographical facts which may have been provided to you, in the Programming, and in any related or derivative versions and/or uses of the Programming (including, without limitation, any serialization(s), translation(s) and/or adaptation(s) thereof), and in the advertising, marketing and promotion of the Programming and/or Company in all mediums and/or media, including but not limited to merchandising of the Programming, its related products and/or Company. I confirm that, to the best of my knowledge, that the Materials and Performance (if any) are original to me and will not violate or infringe upon any third party's rights.

I agree that, at no cost to you, I have secured, or will secure (and/or will arrange with any respective publisher and/or third-party owner to secure) all rights, including, without limitation, sample clearance and synchronization rights necessary for you to use any master recording(s) and/or musical composition(s) written, co-written and/or performed by me that is exploited for the Contest and/or contained within the Programming. Notwithstanding the foregoing, nothing in this release shall affect my right, or the right of any authorized publisher or co-writer, to collect public performance royalties.

I hereby agree not to sue and irrevocably and unconditionally remise, release, waive and forever discharge Company, its parent and related companies, subsidiaries (whether or not wholly-owned), affiliates, divisions, and their past, present and future officers, agents, representatives, employees, successors and assigns, jointly and individually (hereinafter collectively referred to as "Releasees"), from any and all manner of liabilities, claims and demands of any kind or nature, whatsoever, in law or equity, whether known or unknown, which I (or my assigns, agents and/or representatives) ever had, now has, or in the future may have against the Releasees, including, but not limited to claims arising out of or related to the uses described herein, the Contest, the Programming, the Performance, and/or my decision to participate in any of the foregoing. I further agree in the event I bring a claim or lawsuit in violation of this agreement, I shall be liable for any attorneys' fees and costs incurred by Company in connection with such claim or lawsuit. In no event shall I have the right to enjoin the development, production or distribution or exploitation of the Contest or the Programming. Company may transfer and assign this agreement or all or any of its rights or privileges hereunder to any entity or individual without restriction. This release shall be binding on all of my successors-in-interest and heirs. This agreement sets forth the entire agreement between us with respect to the subject matter hereof and may not be altered or amended except in writing signed by both parties. This agreement, its validity, construction and effect shall be governed by the laws of the State of New York. The parties hereto agree to submit to jurisdiction in the State of New York.
